UNDERTAKING

M/s. Jio Digital Fibre Private Limited has applied for diversion of Forest area for laying of underground Optical Fibre Cable along the National Highways/State Highways road.

In Government of India guidelines of Forest (Conservation) Act, 1980 in F.No.5-3/2007-FC, dated 05.02.2009, payment of Net Present Value for underground laying of Optical Fibre Cable has not been allowed, if the area does not fall within a National Park / Sanctuary and no felling of trees is involved.

The above area is not declared as National Park / Sanctuary. For the execution of the above work, felling of trees of any nature (Planted / Spontaneous growth) will not be done and alignment will be carried out to avoid removal of trees in the alignment path. Hence Net Present Value is not payable in the present case.

However, if subsequently any clarification / order is issued by the Central Government / Hon'ble Supreme Court of India to the contrary, we undertake to make such payment on issue of a demand note by the State Forest Department / Competent authority.

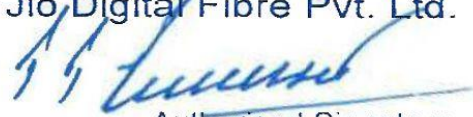
