

1. OFC laying work will be executed within the Right of Way on road side. No work will be executed outside of ROW.
2. The soil work done during execution of OFC work we will make good the land after use / maintenance.
3. During execution of OFC laying work we will not damage any forest property and will not cut any tree or damage any tree. Still if it is required work will be carried out as per forest Department Guidance.
4. For maintenance work in OFC line we will take permission from forest Department.
5. The width of trench will be 0.45 mtr and depth will be not more than 1.65 mtr.
