With reference to above subject, it is to bring to your kind notice that, during 03.09.2003 forest land to an extent of 221.80 Ha was leased to KREDL on behalf of M/s Enercon India Limited (Now M/s Wind World (India) Limited) for implementation of wind power project, for a period of 15 years to encourage the wind developers in Karnataka during the initial period.

Now M/s Wind World (India) Limited (Earlier M/s Enercon India Limited) has requested KREDL vide letter cited under reference (3) for extension of forest land lease for a further period as the lease period expires.


