In the reference first cited, the Superintending Engineer, R&B, NH Circle, Ananthapuramu, has reported that proposals were submitted through online for diversion of 3.58 ha forest land for "For laning of National Highway from KM. 368/900 - 424/225 of *Dharwad*-Gooty-Krishnapatnam Port Road., ie., from Karnataka/Andhra Pradesh State Border to Gooty Section of NH-63 (New NH-67)". The Prl.Chief Conservator of Forests, A.P., Hyderabad has requested to upload the RoFR (Recognition of Forest Rights) details through online.

The Divisional Forest Officer, Ananthapuramu in the reference 5th cited, has submitted that " there are no claims either individual or community pending in the Forest land proposed for the diversion of widening of road from Gooty to Guntakal on N.H.63 under ROFR Act. Therefore the certificate in Annexure-I may please be issued to the N.H.authorities for uploading the diversion proposals under Forest (Conservation) Act, 1980."

Hence, I enclose herewith the RoFR in prescribed format of Annexure-I, Form-I approved by the District Collector, Ananthapuramu as requested.
