1. Project details :

- (i) Short narrative of the proposal and project/scheme for which the forest land is required.

With the view to make the Country clean, hygienic and healthy socially and economically, the Government of India has launched "SWACHH BHARAT MISSION (GRAMIN)" on 2nd October, 2014. It is a Flagship Rural Sanitation Program targeted to make the Country swachh in all respect and Solid Liquid Resource Management (SLRM) initiatives are the integral part of this programme. Hence, in order to initiate the Project, the Govt. has decided and directed to construct a Resource Recovery Centre in all the Blocks under Block Administrative Centre and directed the BACs to prepare DPR, which has already been approved by the Government. So, as per the letters followed by Guidelines, Circulars issued by the Government of Sikkim, it was advised to identify a Forest land for construction of the RRC in case private land is not available. Accordingly, the BAC made efforts to identify the land in private holdings but unfortunately, failed to identify the land. Subsequently, a joint verification was conducted by the BAC Officials with Revenue Supervisor/LR & DMD and the Forest Deptt. and a plot of land measuring area .1010 Hect. under Forest Khasmal at Sangadorjee block, Rinchonpong, West Sikkim has been identified.
