


It is further certified that.

- d) The discussion and decision on such proposals had taken place only when there was quorum of minimum 50% of the members of Grama sabha present.
- e) The diversion of forest land for facilities and managed by the Government as required under section 3(2) of the FRA have been completed in the Grama sabha have given their consent to it.
- f) The rights of Primitive tribal Groups and Pre-Agricultural Communities where applicable have been specifically safeguarded as per section 3(1) (e) of the FRA.
- g) The proposal does not involve recognised right of Primitive Tribal Groups and Pre-Agricultural Communities.



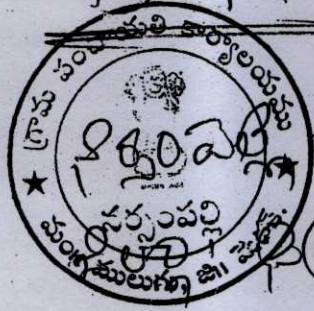
