

It is submitted that, through the reference 3<sup>rd</sup> cited it was asked to furnish the information i.e., list of enumeration of trees in respect of 4.91 Ha. establishment of Administrative building and other infrastructure facilities for Telangana School of Horticulture.

In this connection, it is submitted that as per the orders issued by the Vice Chairman and Managing Director, TSFDC, Hyderabad harvesting has been completed departmentally over an extent of 24.90 Ha. in 2000 EP Narsampally 'B' and 3.10 Ha in 1999 Narsampally 'B.' The mechanical site preparation i.e., uprootal and tillage, collection and dragging of root wood, pit filling and leveling has been completed which includes 4.91 Ha. in 2000 EP Narsampally 'B'. Further it is also to submit that, 100 % enumeration was carried out before harvesting to carryout 100 trees exercise. As per 100 % enumeration total planting points were 24749 no's, 21828 no.of survivals and the total survived stems available were 60537 no's in 24.90 Ha. Accordingly, total planting points were 5535 no's, 5002 no.of survivals and 11936 no.of stems were available in 4.91 Ha. allotted for Establishment of Administrative building and other infrastructure facilities for Telangana School of Horticulture.
