


1. UNDERTAKING TO PAY THE NET PRESENT VALUE



4. UNDERTAKING TO PAY COST OF COMPENSATORY AFFORESTATION

The forest area required for diversion is less than 5.00 Ha and it is falling outside the Protected Area, hence identification of equivalent non-forest land for Compensatory Afforestation is not necessary. However, hereby undertake to bear the cost of Compensatory Afforestation on degraded forest land for planting 10 times the number of trees to be felled or any number of tree to be specified in the Approval Orders as demanded by the Forest Department and also undertake to pay the additional amount if any, due to escalation or any other changes in planting technique etc., at a later date as per the demand raised by the Forest authorities, in-respect of the work "For widening and up-gradation of the existing road from Markodu to Pedduru of Yellandu Forest Division".






