

**Preamble**

A proposal has been submitted to Government of India for renewal of lease of 230 Acres of forest land sanctioned for the establishment of Kuvempu University. In letter under ref(1). It has been requested to transfer alternative govt land suitable for afforestation to Forest Department in accordance with Forest Conservation Act 1980 for renewal of lease by the Govt of India

In accordance with the above proposal land with survey number 38, 39, 40, 45, 46 in Kesavinamane village and land with survey number 49 in Kesavinahakku village Tarikere Taluk, land with survey number 10 in Tigada village have been identified as Govt land. Out of these 80.35 acres in survey number 4 of Kesavinamane village, 80.00 acres in survey no. 46, 70.00 acres in survey no. 49, and 70.32 acres in survey no. 13 of Tigada village- a

total of 301.27 acres have been transferred to Forest Department in accordance with section 71 of Karnataka Land Revenue Act 1964 as per this office order No. No.M4LND CR195:2007-20008 dt 26-05-2009. The remaining land of 648.38 acres in survey no 39, 40, 45, 46, 49 has been transferred to land bank vide govt order noRD106LGC88 dated 20-07-1994.

A proposal was submitted to the Government to release the said 648.38 acres of land from land bank. The Government has approved and ordered for the release of the land and transfer to the Forest Department subject to certain conditions and hence this order

In view of the facts enumerated in the preamble above, in pursuance of Government Order No.RD84LGU2009 Dated 25-01-2009 and section 71 of Karnataka Land Revenue Act 1964, the following land has been transferred to Forest Department for afforestation in lieu of 230 acres of reserve forest land leased to Kuvempu University



