(a)	The state Government has reported that 0.76 Ha is for widening of road to two lane with paved shoulders between Rayachoty and Vempalli section, newly declared NH-440 from Km.0/0 to 53/600 in the State of Andhra Pradesh under EPC mode. However, actual length and width of the road portion to be diverted has not been reported. Moreover as per the kml file, it appears that the User Agency intends to improve only curve by diverting fresh forest area for the purpose of new alignment. Hence, it is requested that the legal status of the existing road and actual length and width of the road proposed may please be submitted.	i)Legal status of the existing road – The road is owned by the(R&B)NH Division,Kadapa Existing road Length - 305.0m Width - 3.50m ii)Actual length and width of the road proposed: Length - 253.33m Width - 30.00m	
(b)	"As the UA proposed for fresh / new alignment for improvement, the old road existing road in the RF area may need to be dismantled and to be restored by plantation of indigenous trees so as to avoid fragmentation of forest area: Specific comments of the State	The existing road in the RF can be dismantled and to be restored by plantation of Indigenous trees.

(c)	Divisional Forest Officer, Kadapa Forest Division in PART II has reported that 2816 number of trees to be felled in the forest area proposed for diversion.
