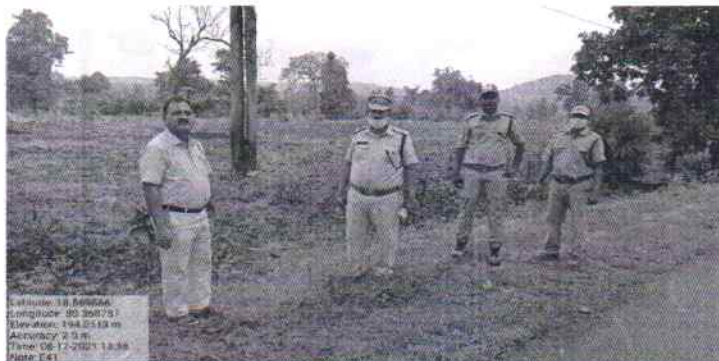

Field Inspection Notes of Sri.J.Gopal Rao, SFS, Forest Divisional Officer (FAC), WLM Eturnagaram 17.08.2021 in Eturnagaram North & Eturnagaram South Ranges, area proposed for Diversion of 0.5873 Ha of forest land in Eturnagaram Division of Mulugu District for laying of Optical Fiber Cable along the Road and within the existing Right of Way for execution of T-fiber Project in the Mulugu District

On 17.08.2021 inspected the area proposed for diversion for Diversion of **0.5873 Ha** in Mulugu District for laying of Optical Fiber Cable along the Road and within the existing Right of Way for execution of T-fiber Project in the Mulugu District in favour of M/s Telangana Fiber Grid Corporation Limited in Compt.Nos. 651, 165, 152a, 152b of Eturnagaram South Range of Manasapally, Chityal and Tadvai RFs and Compt No's 157, 1612f, 7058, 4,5,644, 8a & 8b of Eturnagaram North Range of Tadvai, Singaram South, Rampur Extn, Chityal & Gangaram Extn RFs.
