

Site Inspection report for New B.G.Rail Link Project from 112 RKM to 143.3 RKM from Khurda Road to Bolangir in the District of Nayagarh under Nayagarh Division

Date of Inspection by the Regional Chief Conservator of Forests, Bhubaneswar Circle dated 09th October 2021

- Inspected the site at Pillar No.112.055 RKM where RCC Pillar has been posted.
- Inspected the site at 114.004 RKM at Rangamutia where road over bridge with span of 2 x 61 mtr. is proposed over the National Highway.
- Inspected the site in the Central RF where a tunnel over 2.62 RKM is proposed between 126.42 RKM to 129.04 RKM. The site is a hillock with good vegetation.
- Inspected the Pillar at site 132.235 RKM at Janipadar village where RCC Pillar is posted above ground.
- To minimize the loss of vegetation and tree felling the project proposal envisages construction of underground tunnel over 2.62 RKM and a bridge with 58 span of 24.4 mtr. and 2 span of 30 mtr. to allow smooth passage of elephants.
