

FIELD INSPECTION NOTES OF THE DISTRICT FOREST OFFICER, JAGTIAL ON 26.12.2021 IN CONNECTION WITH THE PROPOSED DIVERSION OF 0.1714 Ha. FOREST LAND IN JAGTIAL DIVISION OF JAGTIAL DISTRICT FOR LAYING OF OPTICAL FIBER CABLE ALONG THE ROAD WITHIN THE EXISTING ROW FOR EXECUTION OF TELESONIC NETWORKS LTD IN JAGTIAL DISTRICT IN FAVOUR OF M/s. TELESONIC NETWORKS LIMITED, HYDERABAD.

As per the instructions issued by the Prl. Chief Conservator of Forests vide reference No.4365/2021/FCA-3, dated: 18.05.2021 the Field inspection for the proposed diversion of forest area for Laying of Optical Fiber Cable along the road within the existing ROW in favour of M/s. Telesonic Networks Limited, I have inspected the site on 26.12.2021.

The proposed Optical Fiber Cable area to an extent of **0.1714 Ha.** is passing through the (03 Nos RFs). The User Agency, M/s. Telesonic Networks Limited has got the area demarcated on the ground. The proposed area having the forest **0.00** density, and there is no trees present. The location wise breakup of the area required by the User Agency is as follows:

Further, the proposed diversion area for the project 0.1714 Ha. (Length: 4284.57 m X 0.40m width) is found correct. The density of vegetation of adjacent forest is 0.40 (Open forests). The general Flora existing in forest area is Teak, Chennangi, Billudu, Nemalinara, Moduga, Rela etc.,. The local Fauna includes Spotted deer,

Neelgai, Sambar, Chinkara, Porcupine etc.,.

There is no scope of soil erosion in the proposed area of diversion. The proposed area of diversion falls inside the reserved forests only (zero meters).

The proposed area of diversion for forest land for laying of the Optical Fiber Cable, which is unavoidable and the area required is barest minimum for the project. The proposed area **does not form part of**



any National Park, Wildlife Sanctuary, Biosphere reserve, Tiger Reserve or Elephant Corridor etc., and in any Eco-Sensitive Zone.

There are no rare/endangered/unique species of flora and fauna found in the area. There are **no protected archaeological/heritage site/defense establishment or any other important monument** in the located area.

Further it is noticed that, the proposed diversion of land is passing through notified RF areas. Hence no RoFR certificate is required.

There is no work in violation of Forest (Conservation) Act, 1980 has been carried out by the User Agency.

Hence, the project proposal for laying of Optical Fiber to an extent of 0.1714 ha in Jagtial Division in favour M/s. Telesonic Networks Limited is recommended.
