No. D(5)-62/IND/2018: In exercise of the power conferred by Rule 4(2) and Rule 5(1) of the Manipur Minor Mineral Concession Rules, 2012 and in consideration of the application No 1/Q/MN/2018 dated 19/11/2018 submitted by M/s. Noren Enterprises, Brahmapur Nahabam, Imphal East for the grant of quarrying lease of Earth/Ordinary Earth, the Director of Trade, Commerce & Industries, Govt. of Manipur is pleased to grant a Quarrying Lease to M/s. Noren Enterprises for quarrying of Earth/Ordinary Earth over an area of 1(one) Hectare at Lhongchin village, Kangpokpi District, Manipur for a period of 10(ten) years commencing on the date of execution of Quarrying Lease Deed within the area bounded by the geographical limits as below:

2. The grant of this lease shall be subject to the following terms and condition:
- Payment of fee, security deposit and financial assurance will be made as per Rule 34, Rule 35, and Rule 40 of the Manipur Minor Mineral Concession Rules, 2012.
 - The lessee is required to submit Mining Plan as provided under Rule 39(4) of the Manipur Minor Mineral Concession Rules, 2012.
 - The lessee shall strictly adhere to the conditions laid down in Rule 39 of the Manipur Minor Mineral Concession Rules, 2012;
 - The lessee shall comply with the related provisions of Forest (Conservation) Act, 1980 and Environment (Protection) Act, 1986 and other rules and Notifications as amended from time to time.
3. The Quarrying Lease Deed shall be executed in prescribed Form-H within six months from the date of receipt of this order as per Rule 43 of the Manipur Minor Mineral Concession Rules, 2012 after fulfilling the conditions required in Sl.No.2(i) and 2(ii) above.
