We write with respect to above referenced letter dated 18.09.2019 and our compliance in seriatim is as under:

The length of survey no. 100 and 98 at Ulawe Village Tehsil Panvel should be measured.

BPCL Compliance: The length is measured and it is incorporated in the area statement.

The statutory status of the area of survey no. 15 and 20 in Sonkar Village, Tehsil Panvel is shown as mangrove according to MRSAC. Length of this area is to be confirmed.

BPCL Compliance: Length in Area of Survey no. 15 as well as S.No. 20 is confirmed & included in revised drawings as mangrove.

As there is no mangrove in survey no.10 of Wahal Village, it is excluded from the proposal, but it should be included in the same, if mangroves are found in that area.

BPCL Compliance: The site is verified and the length is incorporated in Khari (Creek) / Mudflat area and the same is shown as creek mangroves in area statement and accordingly map is also prepared on google.

The area of survey no. 115 of Shirdon village, Tehsil Panvel is a non-classified forest, which is shown in the proposal. Still it is necessary to re-check the proposed land.

BPCL Compliance: The area is indicated as un-classified forest in area statement and also in included in village map.

The area of survey no.91 in Dahivali village, Tehsil Panvel which is noted as "Government of Maharashtra" is shown in non -forest land, this should be corrected.

BPCL Compliance: It is corrected and the area is now shown in non-forest land.

The statutory status of survey no. 173 and reserved forest survey no.173 of Narpoli village, Tehsil Panvel is rectified, but length of the proposed length is still needs to be rectified.

BPCL Compliance: The length of the same is rectified and map prepared accordingly.

7. The topo sheet, map attached with the proposal in the ratio of 1: 50000 is not according to the original dimensions. The topo sheet map in the ratio of 1:50000 should include the proposed route on the demanded land, area description chart, latitude and longitude as well as the list and it should be attached with the topo sheet proposal with original dimensions. Also map of each village should be shown with google image description and map should be included in the proposal with the same.

BPCL Compliance: Separate individual topo sheets (3 No's) on SOI maps are provided depicting all features as said above in scale of 1: 50,000. Also all village maps are superimposed on google map for entire pipeline route.

8. The proposal should include the certificate from the district collector under Forest Rights Act 2006.

BPCL Compliance: BPCL has already initiated action to obtained certificate from district Collector. Moreover BPCL has submitted an undertaking in this regard and will submit certificate prior to obtainment of in-principle approval from MoEF& CC, Nagpur.

9. Proposal should be attached with the CD of KML file.

BPCL Compliance: Seven CDs of kml file is attached with all seven sets of proposal.

We are submitting seven sets of proposal complying all points as said above for your perusal and processing it to next level.
