**Query 1.** The survey numbers of non-forest areas are not mentioned in area description charts in the proposal. As a result, it couldn't be confirmed whether the provisions of private forest are applicable to non-forest areas. That is why area description charts should include the details of non-forest area with the respective survey numbers (by indicating old and new survey numbers).

**Query 2.** The English translations of attested 7/12 extracts of the affected forest lands are not attached with the proposal.

After fulfilling all the above requirements, sets of 7 copies of proposal are presented to this office.


