**Subject : Proposal of Bharat Petroleum Corporation Ltd. for Diversion of 26.0494 Ha. Of Forest Land to Lay petroleum products pipelines.**  
Your Letter Reference: Javak Kr. B/ 20 / Jamin /1241/ 2019-20 Date: 31-05-2019

Dear Sir

We write with respect to above referenced letter dated 31/05/2019 and our compliance in seriatim is as under:

1. According to the map of the village Ulwe in Panvel tehsil, the statutory status of Survey No.51/0 is 'final acquired private forest'. This should be rectified.

**BPCL Compliance:** The village map for S.No. 51 /0 is now shown as "final acquired private forest".

2. According to the map included in the proposal of Sonkhar Village, tehsil Panvel, the area of survey No. 1, 3 and 16 according to MRSAC which is going to be affected by laying the pipeline is shown in the demand of the forest land, but area of survey no. 15, which is mangrove, is not shown in the demanded land. This survey no. should be included in the demand.

**BPCL Compliance:** Area in Survey no. 15 as well as S.No. 20 is included in revised drawings as mangrove.

3. According to the map included in the proposal of Owle village, tehsil Panvel, the statutory status of survey No.189 which is going to be affected by the proposed pipeline is 'Reserved Forest'. According to clause No. 4 of Indian Forest act 1927. This area is not shown in the demanded land. Therefore, it should be included in the same. Also, the mangrove near the creek should be included in the demanded land.

**BPCL Compliance:** Survey no. 189 actually is 193 now shown as "Section 4-RF". Also the area between Survey no. 175 and water body i.e. creek & mangrove is now added to the village MAP and area statement.

6. According to the map of village Bambavi, tehsil Panvel, the proposed pipeline and the demand of forest land, has been put forward by showing the area of survey No.31 as 'reserved forest'. But the aforementioned land has been transferred to CIDCO after deforestation. If there is a mangrove area in this land, then it should be included in the demanded land.

**BPCL Compliance:** Survey no. 31 has been mentioned as CIDCO ownership in 7/12 extract. It is verified that no mangroves is present on the land and hence it is not included in the Forest Area Statement.

According to the map of village Pargaon Dungi, tehsil Panvel, the proposed pipeline and according to the map of MRSAC, the area of survey No. 1, which is additional to the mangrove land is shown in the proposal, which should be removed.

**BPCL Compliance:** Survey no. 1 is shown as non-forest and one more S.No. 7 is now included in the revised MAP and it is shown as Mangrove and also included in area statement.

8. According to the area description chart in the proposal of forest land acquisition, it is required to include the way of proposed pipeline through the villages Pargaon Inami, Kopar, Karanjade, Vadghar Nandgaon, Vadavali, Turmale and Giravale in the maps.

**BPCL Compliance:** Now village Wahal is also included in the list of non-forest area over and above afore mentioned villages. The pipeline alignment is included for non-forest area also for above villages, as per your requirement.

9. According to the map included in the proposal of village Shirdhone, tehsil Panvel beginning and end of way of the proposed pipeline is not shown in the area of survey No. 114 and survey No. 115

**BPCL Compliance:** The pipeline inside Survey no. 114 is now shown as Non-forest, as it is not having mention of forest on 7/12 extract. Survey no. 115 is now shown as "Unclass Forest" as per given record. Also the revised village maps now depicts beginning and end of proposed pipeline for pipeline route inside survey nos. of all villages.

10. The way of proposed pipeline shown in the map of village Somatane, tehsil Panvel is incomplete. It is necessary to show the beginning and end of way of the proposed pipeline in the map, as it will make the verification of forest land easy.

**BPCL Compliance:** Now the beginning and end of proposed pipeline is shown in the revised map and survey no. 132 is shown as "Section 4 RF"

11. According to the map of village Dahivali, tehsil Panvel there is the mention of 'Maharashtra Government' in the revenue rights record (7/12) of survey No.91. Therefore, it is required to verify statutory status of above survey no. The documents regarding amendment in records of revenue dept. should be attached to the proposal.

**BPCL Compliance:** Survey no. 91 is now shown as non-forest. The 7/12 extracts of survey no. 91 is attached herewith which is indicating that survey nos. 91/4/35 & 91/4/37 belongs to Maharashtra Government, however, rest of the survey nos. are with private owners.

12. Area of demand according to the map of Village Devoli Budruk, tehsil Panvel is included in the proposal, but it is necessary to show the beginning and end of way of the proposed pipeline in the map, as it will make the verification of forest land possible.

**BPCL Compliance:** The revised map now depicts beginning and end of proposed pipeline in above village as per the requirement.

13. It is necessary to show the way of proposed pipeline on the maps of villages which are going to be affected by the proposed the pipeline according to the respective survey no and attach it to the proposal. It is also necessary to attach all the revenue rights records 7/12 documents of all survey nos. of affected villages with the proposal in Marathi and English language.

**BPCL Compliance:** Now all village maps depicts beginning and end of proposed pipeline for pipeline route inside survey nos. of all villages. We are also attaching 7/12 extract of all villages in Marathi & English Language.

14. It is necessary to show the way of proposed pipeline in the topo sheet in the ratio of 1:50000. Also, top sheet should be presented in the original ratio. It is necessary to show the descriptive table of the area of the demanded forest land in the topo sheet and the map of the village.

**BPCL Compliance:** The required drawing is prepared on SOI Map with 1: 50,000 scale showing Lat - Long co-ordinates for start and end of each survey nos. of demanded area in respective villages. The area statement is also included with all details in the new drawing/map.

15. It is necessary to show the sanctuary and environmentally sensitive area in the topo sheet of 1:50000 ratio. Also, the distance of the sanctuary and environmentally sensitive area from the demanded area should be shown.

**BPCL Compliance:** The required drawing is prepared on SOI Map with 1: 50,000 scale showing sanctuary and environmentally sensitive area.

16. The proposal should include the certificate from the district collector under Forest Rights Act 2006.


**BPCL Compliance:** BPCL has already initiated action to obtain certificate from district Collector. Moreover BPCL has submitted an undertaking in this regard and will submit certificate prior to obtainment of in-principle approval from MoEF & CC, Nagpur.

We are submitting seven sets of proposal complying all points as said above for your perusal and processing it to next level.
