Brief Note on Compensatory Afforestation


As per Clause 2.6(i)(b) reproduced as:

2.6. Provision for plantation of specified number of trees by way of CA in certain cases:

“(i) In the following cases, cost of plantation (including ten years maintenance) of ten times the number of trees likely to be felled or specified number of trees as may be specified in the order for diversion of forest land (subject to a minimum no. of 100 plants), shall be levied from the user agency towards compensatory Afforestation:

(b) Diversion of forest land up to one hectare”

Further, considering the above mentioned clause, this office has prepared Compensatory Afforestation of 100 plants in single patch on forest land Co.98/D of Dudu Range having area of 0.10 Hectare.

2. Plantation Model:

Compensatory afforestation over an area of 0.1 Ha of degraded forest land is proposed to be raised. The area selected for this purpose is in Co. 98/D, Beat Margana, which is a degraded forest area and has been proposed for CA. Presently the area supports scattered Chir (*Pinus roxburghii*). Whole of the plantation of 0.1 ha will be raised in a single compact block. The area identified for plantation has also been shown on the attached map. The species to be planted will be mainly Chir and broad leaved species. Total financial outlay for compensatory plantation scheme is Rs. 64152/-. The monitoring will be done as per existing monitoring mechanism in the Forest Department at present and also as per G.O.I instructions.
