2. You are directed to furnish the progress of Establishment of plant and machinery, green belt, Effluent Treatment Plant and Air pollution control devices, by 10th day of completion of subsequent quarter in the Board.
3. Copy of the work order/purchase order, regarding instruction and supply of proposed Effluent Treatment Plant/Sewerage Treatment Plant /Air Pollution control System shall be submitted by the industry till 31/07/2027 to the Board.
4. Industry will not start its operation, unless CTO is obtained under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and control of Pollution) Act, 1981 from the Board.
5. It is mandatory to submit Air and Water consent Application, complete in all respect, four months before start of operation, to the U.P. Pollution Control Board.
6. Legal action under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 may be initiated against the industry With out any prior information, in case of non compliance of above conditions.

This consent to establish (CTE) is granted to M/S ROHILKHAND PROJECTS PRIVATE LIMITED (PHASE -I) Site Address Khasra No.-200, Village-Gausganj Sarai (Bareilly-Shahjahanpur NH 24 Road) Tehsil-Faridpur, District- Bareilly Out of total land area of 32444.65 sq.m., Total Development of RESIDENTIAL PLOTS 111 NOS FOR SALE on plot area of 14631.54 sq.m.

- 1- Project shall comply with the provisions of Environment (Protection) Act 1986, Water (Prevention and Control of Pollution) Act, 1974 as amended, Air (Prevention and Control of Pollution) Act, 1981 as amended.
- 2- Project should obtain consent under provisions of air & water act before final completion. Unit shall be applied for consent to the board before One month from the date of completion.
- 3- Total Industrial effluent and sewage discharge of the unit should not be more than 70 KL/D and for treatment of Industrial discharge industry should installed adequate Capacity of STP and for treatment of domestic/ Sewage waste unit should Septic Tank (for Sewage) followed by effluent treatment Plant and treated water will used/ recycled for green belt and Toilet flushing etc. inside the Premises
- 4- At the project site a display board size 4x6 feet shall be installed the display board for Construction and Demolition rules compliance.
- 5- Project shall develop a proper green belt and rain water harvesting system, For green belt at least 8 feet height plants should be planted which shall be properly protected as proper manner. For the development of the green belt the guidelines issued vide Board office order no. H10405/220/2018/02 Dt. 16-02-2018 shall be complied.
- 6- Project shall comply with the order passed by Hon'ble NGT and others Hon'ble Courts from time to time.
- 7- Project shall use clean fuel as far as possible.
- 8- Project shall not start gaseous emission & sewage generation without prior consent of the board.
- 9- All construction activities shall be according to authority guidelines.
- 10- The dust emission from the construction sites will be completely controlled and all precautions will be taken in that behalf.
- 11- Project shall comply with the provisions of Construction & Demolition Rules 2016 & MSW Rules 2016.
- 12- Project must be obtaining approval on map from Bareilly Development Authority Bareilly and approved map submit to this office.
- 13- Unit will put tarpaulin scaffolding around the area of construction and the building for effective and efficient control of dust emission generated during construction of the project.
- 14- Storage of any construction material particularly sand will not be done on any part of street and roads in the project area.
- 15- The construction material of any kind stored on site will be fully covered in all respect so that it does not disperse in the air in any form.
- 16- All the construction material & debris will be carried in trucks or vehicles which are fully covered and protected so as to ensure that the construction debris or construction material does not get dispersed into the air or atmosphere in any form whatsoever.
- 17- The dust emission from the construction sites will be completely controlled and all precautions will be taken in that behalf.
- 18- The vehicles carrying construction debris or construction material of any kind will be cleaned before it is permitted to ply on the road after unloading of such material.
- 19- Every worker working on the construction site and involved in loading, unloading and carriage of construction debris or construction material shall be provided with a mask to prevent inhalation of dust particles.
- 20- Unit should obtain valid land use from Bareilly development Authority, Bareilly Consent to Establish in only valid with proper land use.
- 21- All medical aid, investigation and treatment will be provided to the workers involved in the construction of building and carrying of construction of building and carrying of construction debris or construction material related to dust emission.
- 22- The transportation of construction material and debris waste to construction site, dumping site or any other place will be carried out in accordance with rules.
- 23- Fixing of sprinklers and creation of green air barriers will be done to control fugitive dust emissions and improve the environment.
- 24- Unit shall obtain No Objection Certificate from State Ground Water Authority Lucknow /DGWMA, Bareilly before extraction of ground water.
- 25- Unit shall install proper facility for disposal of municipal solid waste.
