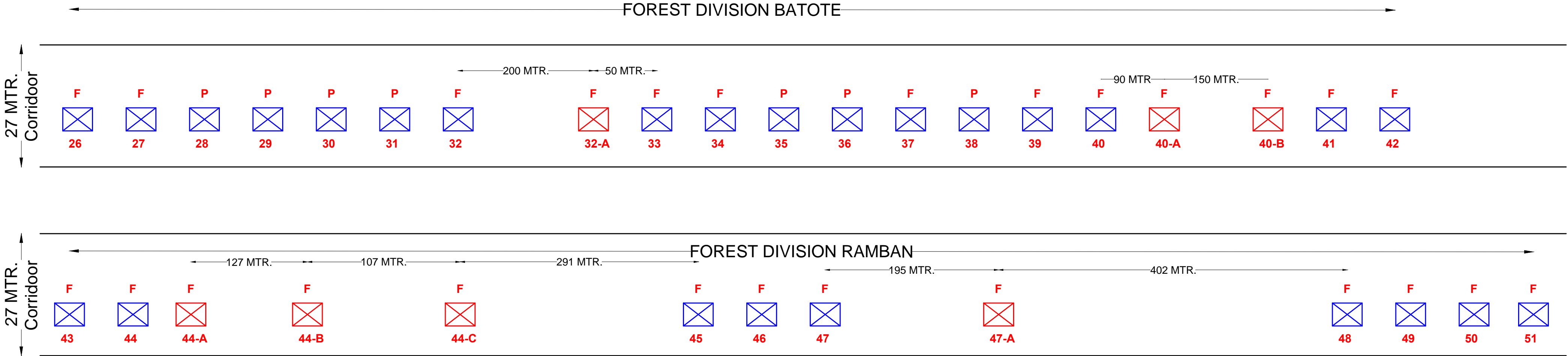


LINEAR PLAN OF 132 KV D/C RAMBAN SANGALDHAN TRANSMISSION LINE

- 1. LAND MEASURING = 7.2765 HA. FOR TOWER NO.: 26,27,32,33,34,37,39,40,41,42 GOT ALREADY DIVERTED VIDE FST NO. 400/FST/OF2018 DT. 27.12.2018.
- 2. LAND MEASURING = 1.34 HA. FOR TOWER FOUNDATION AND LINE CORRIDOOR FOR TOWER NO. 32-A, 40-A, 40-B, NEEDS TO BE DIVERTED.
 - a. DISTANCE BETWEEN 32 TO 32-A = 200 MTRS.
 - b. DISTANCE BETWEEN 32 -A TO 33 = 50 MTRS.
 - c. DISTANCE BETWEEN 40 TO 40-A = 99 MTRS.
 - d. DISTANCE BETWEEN 40-A TO 40-B = 150 MTRS.TOTAL AREA = 499 MTRS.
(WIDTH OF CORRIDOOR x 27 MTRS. = 1.34 HA.

- 2. LAND MEASURING = 3.03 HA. FOR TOWER FOUNDATION AND LINE CORRIDOOR FOR TOWER NO. 44-A, 44-B, 44-C, 47-A NEEDS TO BE DIVERTED.
 - a. DISTANCE BETWEEN 44-A TO 44-B = 127 MTRS.
 - b. DISTANCE BETWEEN 44-B TO 44-C = 107 MTRS.
 - c. DISTANCE BETWEEN 44-C TO 45 = 291 MTRS.
 - d. DISTANCE BETWEEN 47 TO 47-A = 195 MTRS.
 - e. DISTANCE BETWEEN 47-A TO 48 = 402 MTRS.TOTAL AREA = 1122 MTRS.
(WIDTH OF CORRIDOOR x 27 MTRS. = 3.0294 HA. (SAY 3.03 HA.)
