

**DIVERSION OF 3.2180 HA. OF FOREST LAND FOR CONSTRUCTION OF LINK ROAD FROM
DHAR TO DHANGAR via LUNSU IN DISTRICT KANGRA (H.P.)**

DETAIL NOTE ON THE PROJECT

The proposal is hereby submitted for the construction of Link road from Dhar to Dhangar via Lunsu RD 0/0 to 6/500 Km in Tehsil Dehra, District Kangra (H.P.). The said road starts from Village Chatra and links village Ckakla, Dhangar Khas, Dhar and Tillu in Tehsil Dehra in District Kangra (H.P.). The total length of the road is 6/500 km. The road will connect the most backward villages of District Kangra which are only connected with railway line and that too is disrupted during the rainy season. Most of the villagers have migrated to cities and the remaining are still waiting for the road connectivity.

Taking into consideration of urgency of road to provide link to above villages, which is very important for connectivity and to carry their food grains and other basic commodities including providing medical facilities, the proposal is being submitted for approval.

It is further mentioned that between km. 0/0 to km. 4/500, there already exists a katcha road since long time. This path is used by the surrounding villagers. The road alignment will follow this path. There is no other suitable non-forest land available in the vicinity.

The Project Comprises of the following civil works.

- Road Alignment
- Dumping Sites I and II

The adverse impact of the construction on the environment shall be taken care of. Cut & fill method shall be used for disposal of muck/debris would be used in filling the embankments of different structures, retaining walls and low lying areas and the remaining shall be dumped at the dumping sites proposed. Thus every care shall be taken to minimize the ill effect on the environment.

LOCATION OF THE PROJECT:

The said road starts from Chatra village and links with Chakla, Dhangar Khas, Dhar and Tillu Villages via Lunsu in Tehsil Dehra in District Kangra (H.P.).

JUSTIFICATION FOR LOCATION THE PROJECT IN FOREST AREA:

The proposed link road from Dhar to Dhangar via Lunsu in Tehsil Dehra, District Kangra is feasible in the forest land only. Apart from the Private / Govt. land proposed, there is no other Non Forest land available in the concerned area. There is already kutchra road along the proposed alignment which is being fully utilized. All measures have been taken to avoid / minimize the forest land. Keeping in view the existing Kutchra path this alternative has been adopted to minimize the forest land.

Total Population Benefited:


The population of approx. 850 persons living in the surrounding area of village Chatra, Chakla, Dhangar Khas, Dhar and Tillu will be benefited.

Project objectives:


- Provide all weather road to local people.
