Looking into the need of the denizens of the district and the length of the pendency of the project it has been the need of the hour to recommend the acceptance of the proposal for the integrated development of the entire Kalahandi, Balangir, Nuapada, Subarnapur districts in general and the Boudh district in particular. Hence, the proposal for the diversion of 302.329 Ha of Forest Land for construction of Khurdha Road -Balangir new BG rail Link project from 143.33 Km to 180.00 Km is recommended.
