Subject : Rihand Super Thermal Power Station Stage-I.

Sir,

I am directed to convey the approval of the President of India in terms of Article 35 of the Articles of Association of the National Thermal Power Corporation (NTPC) to the capital investment in the scheme of Rihand Super Thermal Power Station in Mirzapur District of Uttar Pradesh.

I. SCOPE

The power station in first stage will comprise installation of 2 units of 500 MW each. The lay-out planning of the station should be done in such a way that the station could be expanded by another 2000 MW subsequently.

II. ESTIMATED COST

The total estimated cost of the scheme will not exceed Rs.1033.00 crores as per the following break up :

(i) Power Station facilities	Rs. 749.6 crores
(ii) Customs duty	Rs. 196.6 crores
(iii) I.D.C.	Rs. 74.5 crores
(iv) Working Capital Margin	Rs. 12.3 crores
TOTAL	Rs. 1033.0 crores

The detailed Break-up for (i) above is given in Annex.-I to this letter.

III. TIME SCHEDULE :

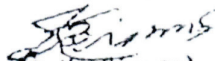
The target for commissioning of the first unit would be June 1987 and the second unit within a period of one year thereafter.

This sanction issues with the concurrence of the Finance Branch of the Department of Power vide their Dy. No. 191/Fin./82, dated 24.6.1982.

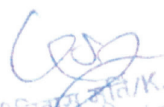

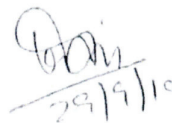
