This is w.r.t. above mentioned subject and references, we hereby furnishing point wise clarification to the observations for your ready reference.

Point No. 1:

On the village map presented in the proposal, which route will be used for transporting materials for undertaking development work in the proposed area? This route is not shown on the map. Also, mangrove forest area on the road to be used is shown as per MRSAC Map.

Material transportation for development work in proposed area will be brought through creek. The Proposed approach road will connect to existing road which will ultimately connect to National Highway – 166A. Map showing existing road to proposed site is enclosed as **Attachment – 1**.

Point No. 2:

In the project proposal, project boundary is adjoining to notified mangrove forest of Survey No. 346 and other survey numbers of mangrove forest. After approval of the project proposal, it is mandatory to conduct joint survey with DILR and Forest Department before starting any development work in the demanded area.

Joint survey will be conducted after approval of project proposal.
