




Further a central nursery is existing from last 20 years with an extent of 3.00 Ha in the proposed area which cater the requirement of nursery for raising of plantations in and around the surrounding beats and distribution of seedlings to public. Nursery infrastructure has been fully developed in the Nursery centre where there is a borewell, pipeline, water tank etc., In addition to the above there are two (2) quarters of Forest Beat Officer and Asst. Beat Officer existing in the (3) Ha. Areas. This area is quite essential to the department and needs to be excluded from the proposed diversion.

Hence recommended the proposal duly excluding the nursery site to an extent of 3.00 Ha.
