**Preamble:-**

The Finance Department vide letter read at(1) has recommended to NABARD to consider the proposals of Water Resources Department (Major & Medium) relating to eight filling up of tanks and other works amounting to Rs.7589.00 Lakhs under RIDF-XXIII tranche.

NABARD vide letter read at (2) has communicated the sanction of work viz; **"Filling of Tanks of Kadagarni and Ullavi villages by Lifting Water from Kaneri river near Amboli village in Joida Tq, dist Uttara Kannada(MJ23002)"** amounting to Rs.1203.33lakhs with a loan assistance of Rs.1143.16lakhs, which is one among the above said eight works. So this work is considered for according administrative approval. Hence the following order.
