The Government of India through National Highways & Infrastructure Development Corporation Limited (NHIDCL) have decided to undertake construction of Moreh Bypass from NH-39 near Indo-Myanmar Border to Land Custom Port of India to bypass the Moreh Town (Length=less than 5 Km approx.) in the State of Manipur. The scope of this project includes improvement of existing Road section to 4 lane /2 lane standard to bypass Moreh Town.

NHIDCL is submitting project details for Forest Clearance for Moreh Bypass section in district Chandel. In this regard, prior approval of the project under section 2 of Forest(Conservation) Act, 1980 by the Central Government a certificate in FORM-I (for Linear Project) of Annexure-I prescribed vide letter F. No. 11-9/98-FC (Pt) dated 05-02-2013 of the Ministry of Environment and Forest (Copy enclosed) to be issued by concerned Deputy Commissioner is mandatory. As per information published by the Ministry of Tribal Affairs, Government of India, there is only Marram Naga group of Primitive Tribal Group (PTG) namely, Marram Naga (Copy Enclosed). Under the circumstances, obtaining of consent of the concerned Gram Sabhas as stipulated may not be required as per office circular of Ministry of Environment and Forests, Government of India, referred above.

This project under Ministry of Road Transport & Highways funded and is a time bound project. It is therefore requested that the issue of the certificate in FORM-I (for Linear Project) of Annexure-I be kindly expedited to ensure timely start of the project.
