Today on 18<sup>th</sup> day of Month May, 2021, during search of the forest the following loss are found :

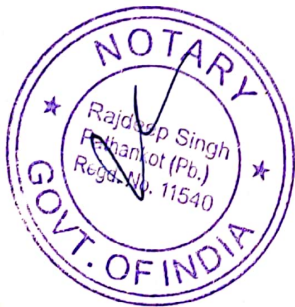
