General Manager (Technical) and Project Director, Mumbai JNPT Port Road Company Ltd., has submitted a proposal of Change of alignment for the diversion of 1.0364 Ha. of forest area for change in alignment of NH-4B, SH-54 and Amra Marg on boundaries of proposed Navi Mumbai International Airport in the State of Maharashtra to be executed EPC Mode in Raigad district.

The construction work of widening of NH-4B is completed by the project authority i.e., General Manager (Technical) and Project Director, Mumbai JNPT Port Road Company Ltd., National Highway Authority of India. The project authority has agreed regarding violation of Forest Conservation Act, 1980 and its guidelines and submitted violation note in prescribed format.

The User agency submitted Forest (Conservation) Act, 1980 proposal for seeking approval for diversion 1.0364 ha. forest area.

In this project the user agency has accepted the offence, hence action as per guidelines para-No. 1.21 (ii) is to be proposed.

As per guidelines penalty amount is calculated as under:

- 1.21 (ii) a. Penalty amount = NPV X 5 = 756572 X 5 = 3782860/-
 - (ii) b. For public utility projects of the government the penalty shall be 20 % of the penalty proposed in para (a) above i.e. 20% of Rs. 3782860/- = 756572/-

In this project, the whole proposed area has been violated. Therefore, penal Compensatory Afforestation scheme will be proposed on equivalent to violated area i.e., 1.0364 ha.
