Subject: Transfer/Allotment of State Land in lieu of Forest Land for construction of Cafeteria by Tourism Department at Village Dogrian Tehsil Surankote.

Whereas, Tehsildar Surankote has submitted Revenue papers of land measuring 10 marlas out of Khasra No. 12 of Village Dogrian for construction of Cafeteria with Public Convenience along Mughal Road vide his No. OQ/SKT/1354 dated 30-09-2021. The type of land is **Gair Mumkin Jungle**.

Whereas, Revenue papers were submitted to Chief Executive Officer, Poonch Development Authority for Feasibility Certificate vide this Office No. DCP/LA/912-14 dated 06-11-2021.

Whereas, Chief Executive Officer, Poonch Development Authority, Poonch has placed Formal Indent for construction of Cafeteria with Public Convenience along Mughal Road at Village Dogrian, Tehsil Surankote vide his No. CEO/PDA/2021-22/479-81 dated 08-11-2021.

Whereas, Chief Executive Officer, Poonch Development Authority, Poonch has processed the case on PARIVESH Portal for transfer to Forest land for construction of Cafeteria along Mughal Road.

Whereas, Chief Executive Officer, Poonch Development Authority, Poonch has requested for identification of State land measuring 10 Marlas for its diversion to Forest Land vide his No. CEO/PDA/2021-22/684-86 dated 16-03-2022.

Whereas, Chief Executive Officer, Poonch Development Authority, Poonch has requested for a Certificate regarding non-availability of suitable alternative non-Forest land/State land vide his No. CEO/PDA/2022-23/390-92 dated 29-08-2022.

Whereas, Tehsildar Surankote was directed vide this Office letter No. DCP/LA/2333-35 dated 01-09-2022 to furnish a Certificate regarding non-availability of suitable alternative non-Forest land/State land for construction of Cafeteria and Public Convenience along Mughal Road. Tehsildar Surankote vide his Office letter No. OQ/Skt/796 dated 10-09-2022 has submitted that no alternate State land is available between Village Chandimarh to Pir Gali along Mughal Road.

Whereas, Certificate regarding the non-availability of suitable alternate non-Forest land/State land along Mughal road was provided to Chief Executive Officer, Poonch Development Authority, Poonch vide this Office letter No. DCP/LA/2405-07 dated 14-09-2022.

Whereas, Chief Executive Officer, Poonch Development Authority, Poonch has requested to provide 10 marlas of State land in lieu of 10 marlas of Forest land identified out of Khastra No. 12 of Village Dogrian vide his No. CEO/PDA/22-23/552-56 dated 16-11-2022.

Whereas, Tehsildar Surankote was directed vide this Office letter No. DCP.LA/274-77 dated 22-11-2022 to identify 10 marlas of State land in lieu of identified Forest Land for construction of Cafeteria and Public Convenience along Mughal Road.



Whereas, Tehsildar Surankote has identified State land measuring 10 marlas out of Khasra No. 13 of Village Dogrian and submitted Revenue papers of identified State land vide his No. OQ/Skt/1107 dated 28-11-2022 and reported that Khasra No. 13 is within the vicinity of Khasra No. 12. The type of identified land is "**Gair Mumkin Katha**".

Therefore, in view of the above, State land measuring 10 marlas out of khasra No 13 with type as **Ghair Mumkin Katha** of Village Dogrian, Tehsil Surankote, District Poonch is hereby transferred/allotted to Forest Department in lieu of Forest land measuring 10 marlas bearing khasra No. 12 of the same Village identified for construction of Cafteria and Public Convenience Centre alongwith Mughal Road.
