The water supply scheme Bainsta is ongoing scheme and the work stands allotted to the contractor under the scheme, one no. pump room building is required to be constructed near the already existing GSR of 10000 glns. Capacity at Pinga Da Talab of village Bainsta. Undersigned had requested for demarcation of title of land vide this office letter No. JSDU/3206-10 dated: 03-09-2020, the revenue officials from the office of Tehsildar Ramnagar along with Forest Officers visited the spot and verified that the land belongs to Forest department.
