Abstract:- Electrification work of Kayattuva- Thodakkayam area under Electrical Section, No.1 Kothamangalam- obtaining Forest clearance- submitting the report on admittance of certain clauses in G.O.(Rt)No.414/2021/F&WLD Dated, Thiruvananthapuram, 16/12/2021 of Forest & Wildlife (C) Department, Government of Kerala.


3. Letter No.DB1/67/TE/22-23/1081 dtd. 22/10/2022 of Executive Engineer, Electrical Division Muvattupuzha.

Having examined the G.O.(Rt)No.414/2021/F&WLD Dated, Thiruvananthapuram, 16/12/2021, it is necessary to admit certain clauses in the aforesaid G.O. Also The Executive Engineer, Electrical Division, Muvattupuzha in his letter vide ref(3) has directed to submit a report which admits the clauses Nos.1,2,3,4,6,8,9,10,13,14 of the same G.O.


I Gopi.N.K, Assistant Executive Engineer, Electrical Sub Division, Kothamangalam on behalf of KSEB Ltd do hereby solemnly admit the following clauses as stipulated in the G.O.

1. Legal status of the forest land shall remain unchanged.
2. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the Divisional Forest Officer, Malayattoor Division.
3. The User Agency shall make online payment of the cost of Compensatory Afforestation, Net Present Value through e- payment module of forest clearance portal.
4. The State Government shall charge the Net Present Value of the diverted forest land of 0.006 ha from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 28.03.2008 and 09.05.2008 in IA Nos 826 in 566 with related IA's in WP(C)202/1995.
5. All the funds received from the User Agency under the project shall be transferred/ deposited to CAMPA fund only through e-portal (<https://parivesh.nic.in/>).
6. The layout plan of the proposal shall not be changed without prior approval of Central Government.

7. No labour camp shall be established on the forest land.
8. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
9. The User Agency shall sign an agreement with Forest Department before transfer of land to the User Agency.
10. The compliance report shall be uploaded on e portal (<https://parivesh.nic.in/>)



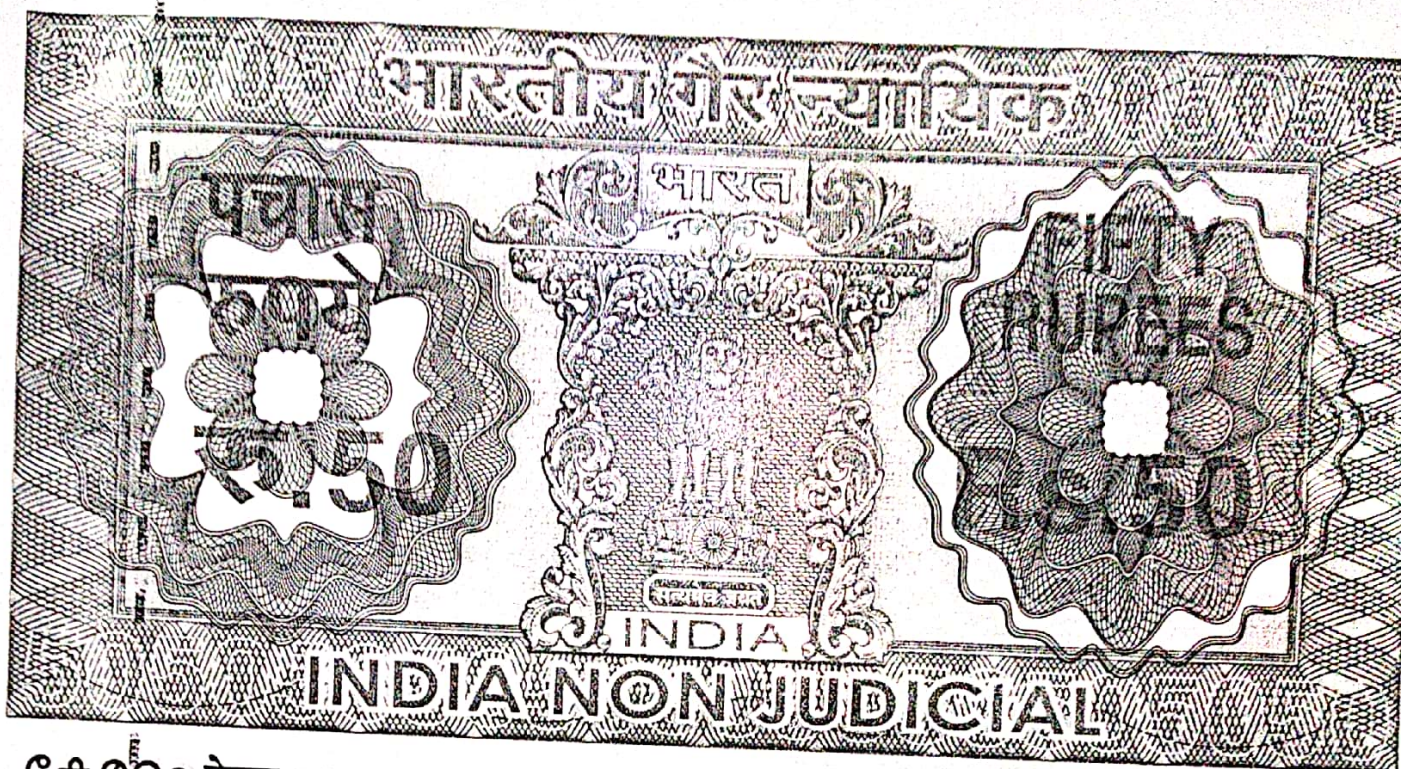
