Keeping in view your office letter no. quoted as above, this office finds the proposal fit in principal for laying natural gas pipeline below the above mentioned Choe/River/Nala and NOC for the same may be granted by concerned Executive Engineer with the following terms & conditions:-

1. The laying of natural gas pipeline will be done strictly as per General Drawings approved by concerned Executive Engineer of Water Resources Department.
2. The drilling Pit will be excavated minimum 10 ft beyond the outer Toe of Bank to avoid disturbance of Phreatic Line and the depths of Top of Pipeline will be not less than 4 metre below the scoured bed level or existing bed level whichever is lower of the above said drain/nallahs/choes. During the process of drilling and installing underground pipelines, the existing condition of drain/nallahs/choes will not be disturbed at any cost.
3. The levels of natural gas pipeline will be in accordance with the Bench Mark of the Choe/River/Nala.
4. By laying the pipe line below the drain/nallahs/choes bed, it will be ensured that normal functioning/flow of drain/nallahs/choes is not affected/interrupted.
5. The work will be carried out as per instruction issued at site under the supervision of concerned Executive Engineer of Water Resources Department, Punjab.
6. In case the natural gas pipeline are affected due to future development and improvement of Choe/River/Nala system by Water Resources Department, Punjab. The cost of laying gas pipeline for relaying rerouting/dismantling of gas pipeline will be borne by the Gujarat Gas limited, Amritsar.
7. The laying of Pipe Line below drain/nallahs/choes, if proposed in flood season will be done only as per approval granted for this by competent authority on the Gujarat Gas limited, Amritsar request and works in all respect inclusive of restoration of drain/nallahs/choes cleaning of muck debris etc, to the satisfaction of the department.
8. All temporary structures constructed during the execution will be removed and the site will be cleared of all the dismantled material within stipulated time period as desired by the concerned Executive Engineer.
9. The laying of natural gas pipeline below Choe/River/Nala will be done only by HDD Method
10. In case NOC is required from other departments for laying natural gas pipeline, the same will be obtained Gujarat Gas limited, Amritsar from respective departments and if there is any damage to the essential services i.e. water supply, sewerage system, telecommunication lines & electricity supply etc. it will be the responsibility of Gujarat Gas limited, Amritsar to get the service restored from the concerned department with immediate effect and the cost so incurred would be borne by the Gujarat Gas limited, Amritsar.
11. Special precaution will be taken by the Gujarat Gas limited, Amritsar for safety of Choe/River/Nala bank and other infrastructure in the vicinity of site where proposed work

- is being undertaken. Clearance from concerned XEN will be obtained by the Gujarat Gas limited, Amritsar before leaving the sites after laying of pipe lines. In case any accident occurs during or afterwards due to laying of pipe Lines, the Gujarat Gas limited, Amritsar will be responsible for the same and will pay for losses and cost of restoration.
12. The concerned Executive Engineer should ensure that there should be no interference to the pucca works in the vicinity of proposed site.
 13. Gujarat Gas limited, Amritsar will abide by the rules/regulations/policy of Water Resources Department. The lease to Government land or any other expenditure like scrutiny fee, use of drainage land for laying the pipes or any other charges as applicable from time to time will be paid by the Gujarat Gas limited, Amritsar.
 14. Executive engineer/Hoshiarpur Drainage Division, Hoshiarpur is directed that the work to be executed from the concerned Agency as per above said terms and conditions. Approval to be issued only after the charges as applicable may be got deposited from the Entity before start of work. As the company will deposit charges for laying the natural gas pipeline for specific Length, the Executive engineer/ Hoshiarpur Drainage Division, Hoshiarpur, will ensure that the company will lay the pipe for the same length and from same location for which Gujarat Gas limited, Amritsar will deposit the Charges as per policy.
