Subject: Regarding grant of NOC for access to mining site on Hisar Tosham road (MDR-108) at Km. 27.507 (RHS) in Village Khanak Tehsil Tosham District Bhiwani (Haryana)

Reference: Online application No. 4879 dated 18.11.2021.


The NOC case for the work cited as subject received vide online application under reference is sent herewith. There is No Objection to issue the NOC to the above said work with the following conditions:-

1. The company will provide one meter width Hume Pipe culverts on both the approaches.
2. The company will not construct katcha or pucca structure on the PWD land.
3. Level of approaches should be kept below the shoulder of the PWD road level.
4. The company will regulate the storm water drainage to avoid damage to the road.
5. The company will supply agreement deed separately to the deptt. for execution of agreement for lease of Govt. land.
6. The company will arrange the drainage of the area of retail outlet in such a manner so that its storm water does not flow on the PWD land in any case.
7. The Longitudinal drainage of the road should not be affected in any manner.
8. The company will not provide any sign board or hoarding which violates the instructions of Hon'ble High Court and Hon'ble Supreme Court.
9. No action of the company will be allowed which will affect smooth running of vehicles on the road.
10. That the service road length 170 Mtr. (70+100 Mtr.) shall be provided by the applicant on his own cost as per guidelines IRC 12/2009 being a (MDR-108) and after construction it is the responsibility of the applicant to intimate this office so that Service road can be checked and final report may be issued.
11. The applicant will received the final NOC from the Executive Engineer after the completion of all Civil Work / Structural work as per instruction by the IRC : 2012.

12. The rent for lease charges of land has been deposited vide DD No.802326 dated 22.11.2021 issued by State Bank of India, amounting to Rs. 10,000/- (Rupees Ten Thousand only) & DD No. 230375 dated 13.12.2021 issued by Punjab National Bank, Toshiam Bhiwani, amounting to Rs. 60000/- (Rs. Sixty Thousand only) for 15 years & thereafter the rent for next fifteen year will have to be deposited regularly and the concern agreement has been made with this department. If any charges occurs on this part time to time will also be applicable on the agency.

1. Department does not confirm the ownership title on the above land. It is the sole responsibility of the applicant who is entering the information.
2. This memo only verifies the location of above stated land viz-a-viz Urban Areas / Controlled Areas.
