The proxy RF boundaries depicted on topomaps are used for ascertaining the entry & exit points of alignment with RF. The division boundaries are ascertained with the help of available records. The extents are then estimated for each division

The maps are enclosed herewith. CFs, Hyderabad & Nizamabad and DFOs, Hyderabad, Medak, Nizamabad & Kamareddy are requested **to verify absolute location of BPs** in field and furnish the entry & exit points of alignment with RFs and to include the patches left over, if any
