The Executive Engineer, TWAD Board, Trichy in the reference 1st cited has stated that in the work of providing combined water supply scheme in Thottiam Union of Trichy district, one collector well cum pump house to be constructed at a distance of 350 M from the Cauvery Rever bund and the foot bridge from collector well crosses the Forest planted area of 2015 Arasalur ETRA (12.56ha) in Padugai Range of Pudukottai Region. The proposed foot bridge area in the Reserve Forest is 0.0934 ha.

2) For the above proposals, the Regional Manager, Pudukottai in the reference 2<sup>nd</sup> cited, has submitted sketch and details of loss to the Corporation as follows:-

## For 0.0934 ha

- Total Expenditure of Raising, = Rs.150118.00Maintenance works
- Pulpwood Cost for three rotations = Rs.99664.00 21.000 Mt X Rs. 4672/MT
- 3) Uprootal of Stumps Cost = Rs. 983.001.248 Mt X Rs.788/Mt
- 4) Damages for Eucalyptus trees = Rs. 29235.00 due to transporting of materials By TWAD Board

Total = Rs.280,000.00

Hence, after payment of the above said amount of Rs.280000/- to TAFCORN, by the TWAD Board, Trichy, the above water supply scheme proposals in Reserve Forest areas may be considered by the District Forest Office, Trichy under the Forest Conservation Act, 1980.
