The Executive Engineer, TWAD Board, Trichy in the reference 1st cited has stated that in the work of providing combined water supply scheme in Thottiam Union of Trichy district, one collector well cum pump house to be constructed at a distance of 350 M from the Cauvery River bund and the foot bridge from collector well crosses the Forest planted area of 2015 Arasalur ETRA (12.56ha) in Padugai Range of Pudukottai Region. The proposed foot bridge area in the Reserve Forest is 0.0934 ha.
