With reference to the above subject, the DGM, SEO, Jio Digital Fibre Private Limited, #51, RMZ Icon, Palace cross road, Vasanth Nagar, Bangalore has submitted the proposal for diversion of 0.759902ha. forest land for laying jio Digital Fiber underground OFC Cable along the road side Right of Way from Halady to Madamakki and Hebri to Varanga villages of Kundapura

Forest Division as per Forest Conservation Act 1980 in Parivesh web portal proposal No. FP/KA/OFC/153022/2022. Vide Ref(1) submitted hard copies of the online proposal in 7 copies to this office.

Accordingly, the forest land proposed for diversion were inspected by Range Forest officer, Shankaranarayana Range and Assistant Conservator of Forests, Kundapura and Range Forest Officer, Hebri, Range Forest Officer, Karkala and Assistant Conservator of Forests, Moodabidre sub division, Moodabidre and submitted the field repot along with concerned forest maps vide Ref (3) to (7). The User agency submitted that the land proposed for diversion is required for laying jio Digital Fiber underground OFC Cable along the road side Right of Way from Halady to Madamakki and Hebri to Varanga villages is optimum and unavoidable. The land required by the User agency in the Reserve Forest measures 0.759902Ha. in Kundapura division, Udupi District.

The user agency submitted that the Reserve Forest area as proposed by the User agency in Col.2 of Part-I is unavoidable and it is a barest minimum requirement for the project and no trees found in the proposed area. The proposed area for diversion falls in Westarn Ghat hills terain, susceptible for land slide. The user agency should takeup all necessary measures to avoid possible land slide.

The User agency submitted an undertaking to pay the NPV and also to bear the cost of Other Charges. The 0.759902ha. of forest area is may be considered for diversion under the Forest (conservation) Act, 1980.

Proposal No. FP/KA/OFC/153022/2022 now submitted in 04 copies along with documents pertaining to the proposal for diversion of 0.759902ha. forest land as per forest conservation act 1980 for further necessary action.
