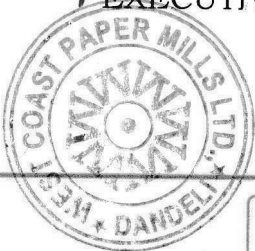





In compliance of the ministry of Environment and Forests(MOEF)Government of india's letter No.11-9/98-FC(pt)dated 3rd august 2009 wherein the MOEF issued guidelines on submission of evidence for having initiated & completed the process of settlement of rights under the Scheduled Tribes & other Traditional dwellers(Recognition of Forest Rights)Act 2006('FRA',for short)on the Forest land proposed to be diverted for non-forest purposes read with MoEF issued certain relaxation in respect of linear projects, it is certified that **20 Hectares of Forest land proposed to be diverted in favour of DEPUTY GENERAL MANAGER -LIASION, West-Coast Paper Mills Ltd, Dandeli for Lease Renewal of establishment of Effluent Treatment Plant Stage-II of forest land (Sy No 22) in Karwar (Uttara Kannada) district falls within jurisdiction of Kerawada village of Haliyal Tehsils.**



(E)The diversion of forest land for facilities managed by the government as required under section 3(2) of the FRA have been completed and the Gram Sabha have given their consent to it.

(F)The rights of primitive Tribals Groups & Pre-Agricultural communities where applicable have been specifically safeguarded as per section 31(e)of the FRA.





SCHEDULE

TERMS AND CONDITIONS

A. TREATMENT AND DISPOSAL OF EFFLUENTS UNDER THE WATER ACT.

1. The discharge from the premises of the occupier shall pass through the terminal manhole/manholes where from the Board shall be free to collect samples in accordance with the provisions of the Act/Rules made there under.
- 2(a). The sewage/domestic effluent shall be treated in septic tank and with soak pit. No overflow from the soak pit is allowed. The septic tank and soak pit shall be as per IS 2470 Part-I & Part-II.
- 2(b). The treated sewage effluent discharged shall conform to the standards specified in Annexure-I.
- 3(a). The trade effluent generated in the industry shall be treated in the ETP and treated effluent shall conform to the standards stipulated by the Board in Annexure-I
- 3(b). The trade effluent shall be handed over to CETP and maintain logbook of effluent generated & sent every day.
4. The applicant shall install flow measuring/recording devices to record the discharge quantity and maintain the record.
5. The applicant shall not change or alter either the quality or the quantity or the place of discharge or temperature or the point of discharge without the previous consent/ permission of the Board.
6. The applicant shall not allow the discharge from the other premises to mix with the discharge from his premises. Storm water shall not be allowed to mix with the effluents on the upstream of the terminal manhole where the flow measuring devices are installed.
7. The daily quantity of domestic effluent and trade effluent from the industry shall not exceed the limits as indicated in this consent order:
8. The applicant shall discharge the effluents only to the place mentioned in the Consent order and discharge of treated/untreated outside the premises is not permitted.

B. EMISSIONS:

1. 2. The applicant shall maintain log books to reflect the working condition of pollution control systems and also self monitoring results and keep it open for inspection.

D. SOLID WASTE (OTHER THAN HAZARDOUS WASTE) DISPOSAL:

1. The applicant shall segregate solid waste from Hazardous Waste, Municipal Solid Waste and store it properly till treatment/disposal without causing pollution to the surrounding Environment.

1. This consent for Operation is valid for a period from 01.07.2021 to 30.06.2026.
2. This CFO is issued for production of Paper and Paper Board of Capacity 26,666 MT /Month (3,20,000 MTPA) and Captive Power Generation using FBC Boiler of Capacity 74.8 MW.
3. The authorities have paid Rs. 20,00,000/- as Consent fee for 5 years based on the CI of 2347 Crores. The applicant shall pay the balance fee, if any, after the final notification of revised consent fee and as per the affidavit submitted by the industry.
4. The industry has to comply with the conditions stipulated in the Environmental Clearance issued by MoEF.
5. The water consumption and the waste water generation for both domestic and industrial activity shall be as below:

6. The process trade effluent and domestic sewage shall be treated in combined ETP and final treated effluent shall be discharged in to Halamaddi nallah leading to Kali River after confirming to the Standard stipulated in **Annexure-A**.
7. The applicant shall not dig the new Bore wells within the premises.
8. The applicant shall take suitable steps so that there will be reduction of the fresh water consumption as well as waste water generation from the industry.
9. The applicant shall improve the arrangement made for treating surface runoff from the coal handling area in the ETP to prevent the surface runoff reaching the near by water body. The detailed action plan shall be submitted to the Board.
10. The industry shall explore the possibility of reducing the pollution load by adopting advanced waste water treatment technology to reuse/recycle the treated trade effluent to the maximum extent.
11. The applicant shall take up structural stability test to all the civil structures in a phased manner, and based on the report, the applicant shall take up repair/restoration work.
12. The applicant shall take action to periodically clean/remove the solid deposits if any near the confluence point and downstream in the river.
13. The analysis of treated trade effluent shall never exceed the stipulated standard and in any case the treated effluent is exceeding the standard, the applicant shall take appropriate step to maintain the ETP units to ensure treated water always complies with the stipulated standard.

B. DISCHARGE OF EMISSIONS UNDER THE AIR ACT:-

1. The discharge of emissions from the premises of the applicant shall pass through the air pollution control equipment and discharged through stacks/chimneys mentioned in

- Annexure-B** where from the Board shall be free to collect the samples at any time in accordance with the provisions of the Act and Rules made there under.
- 2 If there is going to be any new air pollution sources in future, the project authorities can apply and obtain consent for establishment for the same from the Board.
 - 3 The coal shall be stored in a closed Shed and not be stored in open area/land without any cover.
 - 4 Fugitive emissions in coal handling area, lime kiln area and truck movement area shall be controlled by adopting suitable measures and required control measures shall be taken.

These D. Sets have been provided with 52 m Chimney with Acoustic enclosures.
 - 7 The analysis of stack monitoring shall never exceed the stipulated standard and in any case the stack analysis is exceeding the standard the applicant shall take appropriate step to maintain the air pollution control equipment to ensure stack emission always complies with the stipulated standard.

C. HAZARDOUS WASTES (MANAGEMENT, HANDLING & TRANSBOUNDRY MOVEMENT) RULES 2016:

1. The industry shall apply and obtain authorization under Hazardous Wastes (Management, Handling & Transboundry Movement) Rules 2016, and comply with the conditions of the authorization. The applicant shall comply with the terms and conditions stipulated in authorization.
2. The applicant shall dispose the empty raw material cans back to the supplier and shall maintain the manifesto to this process. The details shall be submitted to the Board.
3. The applicant can sell the boiler ash to the farmers, if farmers are interested, along with press mud and ETP sludge to use as manure in their lands for irrigation.

D. GENERAL CONDITIONS

1. The applicant shall not allow the discharge from the other premises to mix with the discharge from his premises.
2. The Noise generated in the factory shall be within the prescribed limits of 75 dB (A) leq. During day time and 70 dB (A) leq during night time.
3. There shall not be any complaint against the industry on water, air, noise pollution from the surrounding general public.
4. The applicant shall carryout intensive plantation/ thick vegetation all round, especially towards residential apartment to minimize air & noise pollution. The action taken report shall be submitted to the Board immediately.
5. The applicant shall comply with the noise standards for work zone exposure for industrial workers as per the Factories Act/Noise Pollution (Regulation and Control) Rules, 2000.
6. The Storm water shall not be allowed to mix with the effluents on the upstream of the terminal manhole where the flow measuring devices are installed.
7. The applicant shall submit storm water management plan & shall implement the same and submit the action taken report to the Board.
8. The industry shall provide metalled road for transportation of raw materials and finished goods along with metalling of lateral roads.
9. The applicant shall improve the house keeping within the industrial area.
10. The industry shall provide rain water harvesting system within the premises to conserve the Water Source.

11. The applicant shall store the metal scrap, plastic waste, glass wool and other solid waste scientifically in a designated separate shed within the industrial premises and the same shall be handed over to authorized recycler/agency with proper approval from the Board.
12. The applicant shall store the used containers scientifically in a designated separate shed within the industrial premises and the same shall be handed over to authorized recycler/agency with proper approval from the Board.
13. The industry shall provide online emission monitoring system, effluent monitoring system and the data shall be connected to CPCB and SPCB server as per CPCB directions.
14. The industry shall provide separate energy meter to the ETP and flow meter to inlet and outlet of ETP.
15. Left over unused tanks shall be closed or else same shall be utilized for rain water harvesting.
16. The applicant shall dispose the municipal solid waste in a scientific manner as per Solid Waste Management Rules, 2016 and maintain the log book of solid waste generation and disposal details.
