Rectify this contradiction.	The Profile of Applicant has been updated to reflect the name of Shri Rakesh Verma as Authorised signatory for signing the application. The Authorisation letter clearly indicating the name of Shri Rakesh Verma, S.E. as authorised signatory for signing the Forest Proposal of Rath-Garautha Missing Link of SH-42 issued by the Chief Engineer, UPPWD has already been uploaded. All the Documents of Forest Clearance Proposal have been signed by the Authorised person only.
2.	23.2455 ha. Reserve forest land involve in this proposal but In L c(iv), area of non forest land in uploaded KML file of Jhansi and Hamirpur division are 21.3635 ha. which is less then 23.2455 ha. Kindly rectify and re-upload revised KML file of non forest land.	It is already indicated in the L(ii) of Form-A Part-1, that the non-forest to be provided by the User Agency for raising Compensatory Afforestation is less than the area of forest land proposed to be diverted. A total area of non-forest land allocated by the District Authority so far is 20.3315 Ha as indicated in Lc(iv). The allocation of remaining 2.914 ha of non-forest land for CA purpose is in progress and will be submitted to the DFO along with the forest proposal, as soon as the District Collector will

Kindly upload correct geo referenced map of 23.2455 ha. non forest land according to revised KML file of non forest land with title name, legend, sign, seal and date of authorised person	In L(v) the georeferenced map of non-forest land for CA has been prepared according to the above already allocated non-forest land. The map bears correct title of the project and the legend of each component has been provided in the map. The map have been signed by the Authorised signatory with name seal and date.

You are requested to kindly accept our submission and issue the acknowledgement sheet for onward submission of the hard copy of the proposal to the respective offices of DFO and DC of Hamirpur and Jhansi District.
