With reference to the reply provided by the State Government to the point nos 2 & 3 of this office EDS dated 08.06.2022, State Government is requested to submit a map separately showing the area of the previously approved alignment and the proposed alignment.	A map containing previously approved alignment and new proposed alignment, which is approved by DFO has been annexed for kind reference.
2	No corrections have been made with respect to point no. 4, 6, 8, 12 of this office EDS dated 08.06.2022. State Government is requested to do the needful.	The desired correction has been made for following parameters in the following manner: 1. Point no. 4 – The date on SDLC committee is mentioned as 25.11.2021. The copy of complete FRA is annexed for your kind reference. 2. Point no. 6 – The name of area in CA scheme has been mentioned as, “Muni-ki-Reti, Compartment No.3, Shivpuri Range”; 3. Point no. 8 – A detailed justification regarding requirement of 15m width road has been already provided through our letter no RVNL/RKSH/FRST(CORS)/1/2020/CIVIL/RKSH/140 dated 22.06.2022. The copy of letter is annexed for kind reference.

		4. Point no. 12 – Area proposed is not mentioned in following: Justification statement; tree enumeration and work not yet started certificate. The correction was already done communicated through our letter no RVNL/RKSH/FRST(CORS)/1/2020/CIVIL/RKSH/140 dated 22.06.2022 and same was also uploaded online. The copy of the same is annexed for kind reference.
3	In reply to point no. 10 of this office EDS dated 08.06.2022, State Government has submitted that there is an existing kachha marg and no muck will be generated from the construction of road. The State Government is requested to submit the undertaking in this regard duly authenticated by the concern DFO.	The uploaded proforma of muck dumping statement is already signed by user agency and approved by DFO which state that no muck shall be generated. The copy of muck dumping statement or affidavit is annexed for your kind reference.
4	The justification provided for proposing 15m width of the road is not acceptable. The State Government is requested to re-assess the requirement.	In response to point no 8 through our letter no. RVNL/RKSH/FRST(CORS)/1/2020/CIVIL/RKSH/140 dated 22.06.2022, we already have provided a detailed reason. However, a detailed alignment profile and cross-section profile is annexed herewith for better understanding.
