1	The total period for which the land is proposed to be diverted has not been reported and details of the non - forest area required for the project have not been mentioned in PART-I. Hence, the User Agency may rectify the above discrepancies. (UA)	The User agency has reported that, the total period for which diversion if requested is for 25 years.	
2	On Perusal of the KML uploaded for the diversion on google earth, it is noticed that object ID - 6 stretch" does not follow the existing road or cart track entirely. Further, it is noticed that object ID-11, 12, 15, 16, 20, 24, 25, 27, 30, 33, 34, 38, 39, 42 and 44 are following the existing road / cart track only partially. Hence, clarification is required in this regard from the User Agency and the State Forest Department, rectified KML and map may be resubmitted / uploaded for further processing (UA and DFO).	It is submitted that, the user agency has reported that, the proposed OFC line is passing through the existing road / cart track. In this regard google maps are also submitted for the said object Ids (the same is enclosed with the report). Further, it is reported that, during filed inspection it is observed that, the OFC line passing all along the existing road / cart track.	



3	In Part-II, District Forest Officer stated that 35 Nos of stretches are falling within the right of way and 6 stretches are not falling within the right of way, but an existing cart track is present in the field. Whereas, the same is not indicated in the site inspection report by the District Forest Officer. (DFO).	It is submitted that, instructions noted and revised inspection report submitted accordingly.	
4	It was reported that 3 stretches measuring 0.1868 ha falls in Pocharam WLS. Optical Fiber Cable passing through the WLS sanctuary must be entering or existing the ESZ of the WLS. However, such stretches have not been informed by the District Forest Officer as well as the User Agency. All stretches in which Optical Fiber Cable passes through the ESZ need to be informed by the User Agency and SFD. (UA and DFO)	It is submitted that, the user agency has reported that, 3 stretches are passing through Pocharam WLS and after WLS it start with revenue boundary and there is no forest in ESZ area where OFC is passing after Pocharam WLS. The Forest Range Officer, Medak has also reported that, after Pocharam WLS there is no forest where OFC is passing.	
5	Status of the obtaining approval SCNBWL to be informed.	It is submitted that, WL proposals are submitted along with the FC proposals.	
6	District Forest Officer, in its enumeration report, stated that 584 trees / poles are to be felled for the instant diversion proposal. Whereas under 4 (ii) of PART-II uploaded by the District Forest Officer reported only details of 35 trees. Online Part-II of the proposal needs to be updated by the SFD (DFO).	It is submitted that, instructions noted and revised part-II updated in online.	
7	The State Government proposed Compensatory Afforestation over the DFL area. However, as per the provisions of FC Rules 2022, the User Agency shall provide Non-Forest area for CA purpose. Hence, the User agency may be instructed to identify suitable Non-Forest land for CA Purpose. (UA).	The User agency has submitted an undertaking in shape of a letter that, they are ready to transfer the CA NFL land to the Forest Department the process is under progress centrally at one place for the entire project. (Copy enclosed).














