(i)	Short narrative of the proposal and project/scheme for which the forest land is required.	Diversion of forest land to an extent of 0.549 Ha (778.39 M length & 7 M width) falling in Yadadri Bhuvanagiri Division of Ibrahimpur RF for use of access of existing approach road to access patta lands in Sy.No.86 to 90 for agriculture and transporting the farm produce and other farm equipments.

(v)	Cost-benefit analysis (to be enclosed).	Cost Benefit (CB) analysis doesn't arise, as the area proposed for diversion is less than 5.00 Ha.
(vi)	Employment likely to be generated	Daily employment to the agricultural labour as required depending on the season of agricultural activity and for loading and transportation of agricultural products to the market. However, 100 mandays are generated for employment for laying the road.
<b>2.</b>	<b>Purpose-wise break-up of the total land required.</b>	<p>There is no non-forest land approach to reach the agriculture lands, as the land is surrounded by forest area and it is an enclosure and do not have any alternative approach road to reach our lands, except for formation of road through Forest Area, which was in use for many decades. The road which is proposed now for formation was in use earlier also, which is also mentioned as existing cart track and RoW as per the notification issued vide G.O.Ms.no. 436, Forest and Rural Development (For.III) 27.08.1980.</p> <p>The extent of forest land required is as follows:</p>
