In this connection, some observations have been received from your good office vide under reference and point wise reply is as under:





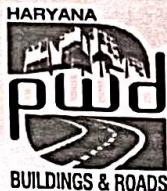
