I submit that, the village Yakaropalli of Pulapathur GP of Rajampet Mandal is not having any road connectivity since attaining of independence.

The people of that habitation are deprived of the basic facilities such as Emergency health requirement, Transportation for public and also for Agricultural produce in addition to the children education to the nearby town for higher studies.

Further, I submit that, the local Hon'ble M.L.A, Rajampet has inspected the village along with the RDO, DFO and EE, Panchayat Raj of Rajampet Division on 13.02.2016, on the request of the villagers to find a permanent solution for the long pending problem of connectivity to the habitation Yakaropalli. Also in this regard it is to submit that, the length of road which is connecting Yakaropalli village from the nearby village Baggidipalli is nearly 3.40Kms. Out of this, the stretch in KM 0/350 to 1/950 is passing through forest land. The balance portion of road i.e., 0/0 to 0/350 and 1/950 to 3/400 was taken up and formation of road was done under local grants. The connectivity is pending in the Km 0/350 to 1/950 for want of permission from the forest department.


In this Regard, a proposal is already submitted to the Revenue Department, requesting to allot the land to an extent of 1.77 HA vide reference 1st cited (Copy enclosed).

Based on this office request, the RDO, Rajampet has submitted proposals to the District Collector for allotment of 4.12 HA to the forest department in Sy.No.707 of pulaputhur village for compensation to the Forest Department for foregoing 1.77HA of land of Forest Land.

It is to submit that DGPS survey was conducted and verification report also received in the reference 6th cited. Hence, further we submitting online proposals seeking prior approval of Central Government, under the Forest conservation Act 1980 vide proposal reference 5th cited please find attached duly filled in application in seven sets for further process.

As you may approve this project shall be completed at top priority basis in the longer interest of all the stake holders.
