With reference to the above subject, & in continuation to this office Ltr cited under Ref (3) I wish to bring the following addl information / clarification for kind consideration as desired in your kind Ltr under Ref (2) for early renewal of lease period.

- Copy of Note containing justification for locating the project in forest land: A signed copy of justification for locating the project in forest land need to be uploaded instead of approval letter and part.
- The forest land in Sy No. 236/1 to an extent of 1.00 HA is very much technically feasible for establishing the 66/11 kv., Sub- Station to cater electric power supply arrangement to Madikeri and surrounding villages as such KPTCL has established the sub-station in the interest of public service.
- Details of land identified for compensatory for station afforestation : though leased area is 1 HA CA land details are not given

- The user agency paid Rs. 44,770/- D D No. 44770 and Rs. 53,730/- DD No. 288549 dated 20.07.2000, the same details as appeared in lease agreement dated 22.11.2011 in Page No. 2 (Sl. No. 04) regarding CA Land to your department.
- The lease period already been expired during the November-2010 itself but you are not still using the said land after of lease period which is in violation to forest (Conservation) at 1980 the should explained
- Previously the said land coming under the jurisdiction of Hassan Zone, Hassan and transferred the assets to the Executive Engineer (Ele) Hootagally division, Mysuru on later date. The delay is caused in handing over of said land. There is no personnel delay caused in renewal of lease period and the 66/11 kv., sub-station very much necessary to cater electric power supply arrangement to Madikeri and surrounding village. In the interest of public service the delay caused, in intimation to this office online and also to receive the same on later date.
- The range forest officer Madikeri range Madikeri as return a letter addressed to the Executive Engineer (Ele), KPTCL, Kodagu Major works, Kushalnagar Vide Lr No. ಪ.ಅ.ಅ ಮಡಿಕೇರಿ : 265 : 2009–10 ದಿನಾಂಕ 18.08.2009 Stating that you have not paid the lease amount for the period 2001 to 2009 amounting to Rs. 10,620/- (including interest) whether the said payment has been made or not if already paid receipting of the same to be uploaded.
- The amount of Rs. 10,620/- (Ten thousand six hundred & twenty Only) towards the lease rent for the period 2001 to 2009 has already been paid vide RT No. 459864 dated 31.03.2010 (DD No. 630296 dated 31.03.2010) the office of deputy conservate of forest Madikeri.

In view of the above facts it is hereby requested to extend the **(Bese**) period from 2010 to 2020 for which KPTCL **(Bese)** ready to pay the necessary lease amount to your department duly observing the corporate formalities.
