Application for No Objection Certificate for setting up a new Retail Outlet on Fatchabad to Hizrawan Khurd Road at RD 3.509 (RHS) in Khewat No. 1335, Khatoni No. 1976, Khasara No. 408//15/1 at Village Daulatpur-Majra Hizrawan, Tehsil and Distt Fatchabad.

The N.O.C for setting up a new retail outlet at proposed location on Fatehabad to Hizrawan Khurd Road at RD 3.509 (RHS) in Khewat No. 1335, Khatoni No. 1978, Khasara No. 408//15/1 at Village Daulatpur Majra Hizrawan, Tehsil and Distt. Fatehabad is hereby issued as approved by the Departmental Committee subject to the following conditions:-

- That the construction work should be taken in hand/ started after taking Nishan Dehi from the Revenue Deptt, and there should be no encroachment on the PWD land which is recorded in the Revenue Deptt.
- 2. If any encroachment found on PWD land after construction, construction will be removed at his own cost.
- There should be no hindrance of any kind to traffic, due to installation of sign board etc;
- No material will be allowed to be dumped on PWD land during construction/setting up a new retail outlet at proposed location in Khasra No. 408//15/1, village Daulatpur.
- 5. As per instruction issued by the department & IRC 12-2009, 0.40 Lacs onetime fee is required to be deposited which has been deposited vide DD No. 918413 dated 12.08.2021 for Rs. 0.40 Lacs & DD No. 007234 dated 14.08.2020 for Rs. 10000/= by the retail outlet owner i.e Sh. Manoj Kumar S/o Sh. Balraj Singh Sihag, Village Jandwala Sotter, Tehsil Ratia, Distt. Fatehabad being ODR as lease charges for 15 years.
- 6. Necessary agreement for lease of PWD land may be submitted before execution of work.
- 7. The oil company/ retail outlet owner will be bound to follow the instructions of PWD 88R Deptt. and IRC-12 of 2009.

8. There should be no encroachment on FWD Land.
