Administrative approval for rough cost estimate for the work by way of widening & strengthening of road from Bhuna to Fatehabad road (SH-2) from Km. 19.700 to 47.375 in Fatehabad District (Road ID 5367 & 5545) (Fatehabad Constituency).

Reference your U.O. No. 584-RII-2021/144858/RII dated 27.08.2021 on the subject noted above.

- The Governor of Haryana is pleased to accord administrative approval amounting to Rs 7999.64 Lakh (Rs. Seventy Nine Crore Ninety Nine Lakh and Sixty Four Thousand only) for rough cost estimate for the work by way of widening & strengthening of road from Bhuna to Fatehabad road (SH-2) from Km. 19.700 to 47.375 in Fatehabad District (Road ID 5367 & 5545) (Fatehabad Constituency) by granting relaxation of 5 years renewal periodicity as per road maintenance policy for the work.
