GRANTING PERMISSION FOR ROAD CROSSING FOR LAYING OF 220 KV D/C GAJNER-CHHATTARGARH TRANSMISSION LINE OF DISTRICT BIKANER IN RAJASTHAN STATE AND RESTORATION/REPAIR WORKS UNDER TAKING THERE OF

1. Reference your letter No. RRVPNL/Executive Engineer (T&C)/Bikaner/Tech./Estt/D 1017 dated 30 Oct 2018 and "undertaking letter No RRVPNL/Executive Engineer (T&C)/Bikaner/Tech./Estt/D 1016 dated 30 Oct 2018" for permission for road crossing for laying of 220KV D/C Gajner-Chhattargarh transmission line of District Bikaner.
2. This permission for road crossing for laying of 220 KV D/C Gajner-Chhattargarh transmission line of District Bikaner is given on the basis of HQ CE (P) Chetak letter No. 20000-A/Gen/77/E2 Wks dated 15 Jan 2016.
3. This permission of road crossing for laying of 220 KV D/C Gajner-Chhattargarh transmission line as accorded will become null & void if, either the work is not commenced within 90 days from the date of issue of this letter or not followed as per the plan. The same will also become null and void if the terms & conditions of the "Undertaking and Joint Inspection Report" as given below are not followed by the Executive engineer (T&C) RRVPN Ltd, Bikaner.
 - (a) That the traffic will not be affected during execution of the work.
 - (b) Provide suitable diversion along with adequate safety measure for traffic during execution of work.
 - (c) Erection of tower is far away from the Right of Way and it will not provide any obstacle in the extension of road in future if required.
 - (d) No claim will be raised by R.R.V.P.N. Ltd Bikaner, Rajasthan at future date in case the Transmission line are to be disturbed/dismantled by BRO for improvement of road or road or for any other technical/administrative initiatives reasons.

(e) All restoration work if occurred will be carried out by R.R.V.P.N. Ltd Bikaner, Rajasthan within 10 days with their own resources to make roads its original shape.

(f) Maintenance and repair of line in future after laying of transmission line, if at all required shall be done by RRVPN Ltd, Bikaner.

(g) "The vertical clearance of transmission line from the road surface to fulfill requirement of ARMY or any other agency in future" will be carried out by RRVPN Ltd, Bikaner without any compensation/claim from BRO.

4. This permission of road crossing for laying of 220 KV D/C Gajner-Chhattargarh transmission line is granted with condition that "Payment to the contractor/subcontractor" by R.R.V.P.N. Ltd will be cleared only after clearance from BRO(OC/ Offg OC 101 RCC (GREF)).



JOINT SURVEY REPORT BETWEEN BORDER ROAD ORGANISATION AND RRVPNL
DONE ON DATED 28 NOV 2018

1. We the undersigned have jointly BRO and RRVPNL Representative has done on dated -- 28 Nov 2018 regarding NOC of road crossing for the laying of 220 KV D/C Gajner - Chhattargarh Transmission line.
2. M/S RRVPNL representative showed all the road crossings. The above said Transmission Line crosses from Noorsar-Pugal-Khajuwala road in b/w milestone 16-17 under the OIC- Sh Kailash Chand, AE (Civ). Also the line crosses from Loonkaransar - Sattasar road at milestone 58-59 under the OIC- Sh B R Singhania, AE (Civ).
3. During the site visit it is found that erection of tower is far away from the road and it will not provide any obstacle in the extension of road in future if required.
4. During the site visit it is found that height of tower is adequate to maintain ground clearance of ~~300~~ 300 mtrs as per RRVPN electricity norms enclosed and thus it will not provide any obstacle in the traffic movement. (Sketch of 132 KV tower enclosed herewith)
5. M/S RRVPNL representative ensured that they will ensure full safety & will not provide any damage to road while laying of transmission line.
6. M/s RRVPNL representative are strictly instructed by OIC that they will inform this office while road crossing & will ensure full safety of traffic movement while laying of transmission line on priority basis.
7. After the site visit it is concluded that OICs of the above areas have no objection in road crossing of 220 KV D/C Loonkaransar -Sattasar Transmission line.
