**Name of the Project: Proposal for diversion of 0.18 ha. Protected forest land for construction of access/approach road to proposed logistics park along with warehouse project, underground water pipeline, electric cable and other ancillary works under old survey no.98/1, new gut no.239/4 of village Kharivali tarf Paulbar, Tal. Wada, Dist. Palghar, Maharashtra**

The proposal is for obtaining the approval of MoEF&CC, Govt. of India for Diversion of 0.18 Ha. Forest Land from Gut No. 239/4 Survey No.98/1 of Village Kharivali tarf Paulbar, Taluka Wada, Dist-Palghar for Construction of Access /Approach Road to proposed Logistics Park along with warehouses project, underground water pipeline, electric cable and other ancillary works. I, the Project Authority, Nehalkumar Hasmukhrai Gandhi, having Co-ownership private areas in Gut Nos. 119,120, 122, 123, 124, 125, 133, 138, 225, 226/1, & 2, 227, 228/1 & 2 & 236 admeasuring 15.5690 Ha. In Village Kharivali tarf Paulbar, Taluka Wada, Dist.- Palghar. Shri Harsh N. Gandhi is also Co-Owner of the said lands.

The Lands in question are agricultural lands with cleared title. We personally examine all possible alternatives for this purpose but there is no possible alternative non forest land available. Hence it is not possible to avoid the forest land, It is unavoidable. Justification in detail is given separately. We purchased 15.5690 Ha private land for

establishment of Logistic park especially to store chemicals brought from different part of the Country and to Distribute it to different Industrial Organizations.

We learn from the Forest Department that the required land is Protected Forest Land. However, the prior permission of the Government of India, under the provision of the Forest (Conservation) Act 1980, is necessary & essential for carrying any non-forestry work in such forest land. Thus we are aware of the fact, that such forest land has comes under purview of the provisions of the Forest (Conservation) Act 1980. The project authority decided to file the Proposal for the diversion of forest land as per the provisions under section 2 of Forest Conservation Act, 1980. Therefore, it is requested to consider our proposal Sympathetically, positively and necessary co-operation may also kindly be given for obtaining such permission from Government of India.
